This three day program focuses largely on chemical dependency education, giving each participant the tools to prevent continued alcohol and drug related consequences. Program participants will receive an individual evaluation and will also take part in a small group experience. In the event that a participant demonstrates symptoms that may indicate a more serious problem with alcohol and/or drugs, an appropriate referral will be issued.

WHAT TO BRING:

- 2. Comfortable clothing, pajamas, etc.

- 5. Reading material, playing cards, etc.

Program Rules

- Our number one rule is that Every Person (staff and participants) will be treated with Respect.
- 2. Check-in is Thursday, between 5:45pm and 6:00pm. Participants must be on time.
- 3. For security purposes, participants and their belongings are subject to search.
- No food items are permitted to be brought from home.
- 5. All participants must arrive in a sober state in order to be admitted; free of alcohol/drugs for a minimum of 48 hours prior to admission.
- Do not bring any valuable possessions. Project Solutions is not responsible for lost or stolen items.
- 7. All medications, to include over the counter products such as vitamins, Tylenol, etc., must be in the original container(s), prescriptions must be current, and must be labeled for the participant.
- 8. After check-in on Thursday, participants are not permitted to leave the facility and are not permitted to have visitors. However, participants are permitted to contact loved ones by phone during breaks.
- Absolutely no weapons are permitted at any Project Solutions Program.
- 10. No person is to commit any criminal offense while a Project Solutions participant.
- 11. Acts or threats of violence toward any person are strictly prohibited and will be cause for dismissal from the program.
- 12. Smoking is permitted only in areas designated by the hotel.
